Greg – please confirm you have a copy of the Proxilogica (PRX) Inventures 2021 pitch deck - to help guide discussions I've attached a one-page brief on PRX along with some comments below:

- David has certain contractual, personal, and ethical obligations summarized as follows:
 - LEAN Systems Limited Partnership (LEAN) was formed specifically to fund PRX and holds the marketing rights. PRX (David) owns roughly 40% of LEAN and via LEAN recently opened a \$1.5M seed round. PRX has been selected as one of the startup finalists for the Inventures Canada 2021 investor event (https://inventurescanada.com/pitch-events/startup-pitch-finalists-andalternates-2021/) (note: covid restrictions forced postponement of the in-person forum scheduled for Sep 22-24 to a virtual event in the 2nd half of Oct).

 - b. Federal gov't collaborations are currently underway with additional groups already targeted and new POC projects to begin shortly.
 - c. In addition to David, PRX employs 3 other key individuals.
- 2. Immediate issues and concerns:
 - LEAN's ability to secure seed round funding to complete the validation stage would be severely hampered in a "founderless" state, rendering pre-seed investment and 3+ years of heavy lifting worthless.
 - Federal grants and wage subsidies have a "benefit to Canada" status and although initially classified as non-repayable can quickly revert to repayable based on non-performance.
 - Although it is likely that the existing staff (minus David) (plus a couple) could complete the technology development, further staff solicitation would be harmful.
 - Non-completion often carries with it adverse, long-term effects on the reputations of all individuals & groups involved - past, present, and future.

Complexity is merely an undefined opportunity – look forward to sharing thoughts tomorrow.
